ABOUT THE PRIMARY CARE PROGRAMS DIRECTORY 2003

This is the 17th edition of the *Primary Care Programs Directory (Directory)*. The *Directory* provides detailed information on Federal programs administered by the U.S. Department of Health and Human Services, Health Resources and Services Administration, Bureau of Primary Health Care (BPHC). These programs support primary health care services to medically underserved, disadvantaged, and high-risk and hard-to-reach populations in the U.S. and its territories. This *Directory* is divided into the following three sections.

1 BPHC-SUPPORTED SERVICE DELIVERY SITES

This is the main section of the *Directory*, and provides detailed information on eight Federal programs administered by BPHC. A brief description of each program is provided below, preceded by a two- to five-letter code. The codes are used in the main section to identify the BPHC program(s) supporting each organization. These codes are listed under “Program Code.”

BL

The **Black Lung Clinics Program** is funded under the Black Lung Benefits Reform Act of 1977 to provide health care to coal miners with respiratory and pulmonary impairments.

CHC

The **Community Health Center Program** is funded under Section 330 of the Public Health Service Act. Community Health Centers (CHCs) provide basic primary medical services to persons living in rural and urban areas who experience financial, geographic, or cultural barriers to care. CHCs also provide enabling services such as transportation and translation as well as preventive health care, mental health services, and dental services.

FQHCLA

A **Federally Qualified Health Center Look-Alike** is a health center that meets the eligibility requirements for, but does not actually receive, any Federal funds.

HCH

The **Health Care for the Homeless Program**, was established under the Stewart B. McKinney Homeless Assistance Act of 1987, and reauthorized under Section 330(h) of the Health Centers Consolidation Act. This program improves access by homeless people to primary health care services and substance abuse treatment; and supports innovative programs for the delivery of outreach, health services, and referral for homeless children and children at imminent risk of homelessness.

HSHC

The **Healthy Schools, Healthy Communities Program**, established in 1994, delivers comprehensive primary care services to at-risk school-aged children through school-based health centers.

ISDI

The **Integrated Services Development Initiative**, began with the funding of Integrated Service Networks in 1994, and shifted toward integrated delivery systems in 1997. Since 1998, ISDI funds have been made available to support two types of projects: Managed Care Networks designed to enhance the ability of federally-supported programs to maintain and increase their base of patients, and Practice Management Networks designed to facilitate integration of delivery systems.

MHC

The **Migrant Health Program** is funded under Section 330(g) of the Public Health Service Act. Migrant Health Centers (MHCs) provide a comprehensive range of primary health services to migrant and seasonal farmworkers and their dependents, and are linked with hospital and other health and social services existing in the area.

PH

The **Public Housing Primary Care Program**, created under the Disadvantaged Minority Health Improvement Act of 1990 and reauthorized under the Health Centers Consolidation Act of 1996, supports the provision of accessible and comprehensive, preventive and primary health care services to improve the health status of residents of public housing.

RS

The **Radiation Exposure Screening and Education Program** was established under the Radiation Exposure Compensation Act (RECA) of 2000, section 417C of the Public Health Service Act, to provide competitive grants to initiate and support programs for cancer screening, medical referrals, and information dissemination.

THE CONTENT OF THIS SECTION IS ORGANIZED AS FOLLOWS:

- The 10 DHHS Federal regions are arranged in ascending numerical order.
- States within each Federal region are arranged in alphabetical order.
- Main organizations within each State are listed in alphabetical order by city.
- Satellite service delivery sites of each main site are listed in alphabetical order by city.

The official corporate name of each main site is printed in bold; any alternate organization name is listed in parenthesis; followed by the types of services provided, languages provided, contact information, counties served, BPHC program support received, and administrative staff. If the address of the main site is preceded by “*Administrative Address*,” no health services are provided at that location. For organizations receiving BPHC special population program(s) support—Black Lung, Health Care for the Homeless, Healthy Schools Healthy Communities, and Public Housing—contact information is provided for the administrator of each special population program listed.

The type of service(s) provided by each organization is indicated by three-letter codes that are provided below. Service types are as defined in Appendix B of the Bureau of Primary Health Care’s *User Manual: Uniform Data System* (included in the Reference Indexes section of this document).

- PMC** Primary Medical Care
- OGC** Obstetrical and Gynecological Care
- SMC** Specialty Medical Care
- DCS** Dental Care Services
- MHS** Mental Health/Substance Abuse Services
- OTH** Other Professional Services
- ENA** Enabling Services

State maps are provided at the back of each of the 10 Federal regions. Each map displays the location of all BPHC-supported main sites and associated satellite service delivery sites for that State.

2 OTHER BPHC-ADMINISTERED PROGRAMS

This section contains key contact information for four additional primary care programs administered by BPHC:

Healthy Communities Access Program Grants: Listing by region, and then alphabetically by State and city with contact information for the grantee contact person.

Hansen’s Disease Grants: Alphabetical listing by State and city with address, phone number, and name of Project Director.

Native Hawaiian Health Care Program Grants: Alphabetical listing by city with contact information for the grantee contact person.

Pacific Basin Program Grants. Listing by territory with contact information for key administrative and clinical staff, and governing board chairperson, if applicable.

3 REFERENCE INDEXES

The first three indexes facilitate locating specific organizations within the main section of the *Directory*. The remaining indexes list Federal offices and State associations that provide oversight or local support to these organizations.

Funding: Matrix listing all main sites alphabetically by State and city; the BPHC program support provided to each; if funded under Section 330, designation as rural or urban; with page cross reference.

User Manual: Uniform Data System, Appendix B: This appendix lists the nine categories of service of the “BPHC Supported Organizations” section of this *Directory* and defines the types of services included within each category.

HRSA Field Offices: Listing of contact information for the Associate Field Director for Primary Care.

State Primary Care Associations: Alphabetical listing by State with mailing address, name and title of chief administrative person.

State Primary Care Offices: Alphabetical listing by State with mailing address and contact person.

SECTION 3 contains reference indexes

There are several ways to quickly and efficiently navigate through the pages to find the information you need. The “Bookmark” area on the left column for each Region provides links to a Table of Contents (TOC), list of States, Section 2, and Section 3.

If you click on a State, you will find information about each main and satellite site(s) in that State. Each page has a link at the top (“Return to TOC”) that takes you back to the table of contents for that Section/Region. Each page has a link at the bottom (“To State Map”) that shows you a State map containing the locations of delivery sites. Main site information also contains a link called “Funding” that takes you to data on funding sources specific to that State.

Sections 2 and 3 have individual TOCs, sets of links, and Bookmarks. Section 2 and 3 TOCs help you quickly find the information you need, and the bookmarks allow you to return to any Region with a single click.



Region IX – California Insets


